NOTICE OF PUBLIC HEARING

Notice is hereby provided that the City of Bethlehem, PA, ("City") will hold a public hearing on August 15, 2024 at 11:00 a.m. in Town Hall Rotunda, 10 E. Church St., Bethlehem, PA 18018, in connection with the City's application for a HOME-American Rescue Plan ("HOME-ARP") Non-Congregate Shelter grant.

Purpose of HOME-ARP Funds. To address the need for homelessness assistance and supportive services, Congress appropriated \$5 billion in ARP funds to be administered through the HOME Investment Partnership Program (HOME) to perform activities that must primarily benefit qualifying populations who are: homeless; at risk of homelessness; fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking; or in certain other populations not included in the above populations (each a "Qualifying Population," and collectively, "Qualifying Populations"). The City is applying for HOME-ARP funds from the PA Department of Community and Economic Development for the purpose of creating a non-congregate shelter through the acquisition and rehabilitation of one or more existing structures. A non-congregate shelter ("NCS") is one or more buildings that provide private units or rooms as temporary shelter to individuals and families and does not require occupants to sign a lease or occupancy agreement. In the event that the acquisition and rehabilitation fails to occur, the City may consider alternative HOME-ARP-eligible methods to create to create a NCS, including without limitation, acquiring real property and constructing a new NCS. Individuals and families from Qualifying Populations will be eligible to apply for and be admitted to the non-congregate shelter.

City's Planned Use of HOME-ARP Funds. The City seeks HOME-ARP funding to support the City's HOME-ARP allocation plan ("Allocation Plan") and the creation of a NCS to serve Qualifying Populations (defined above). The requested funding will support eligible HOME-ARP costs including, without limitation, rehabilitation costs and Administration and Planning expenses incurred by the City and/or its agents.
